Narrative By: HUDSONJE 11/11/2006 05:40
 ON 11-10-06 DEP SMITH AND MYSELF, CPL J E HUDSON, RESPONDED TO 263 MAYAPPLE LANE IN REFERENCE TO A SHOOTING. UPON OUR ARRIVAL AT 1639 HOURS WE OBSERVED A SUBJECT IDENTIFIED AS CHARLES ALEXANDER SMITH SR (DOB- 02-11-66) SITTING WITH A TOWEL OVER HIS RIGHT EYE. SMITH WAS CONSCIOUS AND ABLE TO SPEAK. HE ADVISED THAT HE WAS SIGHTING IN A 50 CALIBER BLACKPOWDER RIFLE WHEN THE GUN BLEW UP IN HIS FACE. THERE WAS A RIFLE LAYING NEAR. THIS RIFLE HAD EXPLODED NEAR THE STOCK. I COULD OBSERVE THAT THE METAL ON THE RIFLE WAS SEVERELY BENT AND DISTORTED. DEP SMITH TOOK PICTURES OF THE WEAPON FOR ME. MR SMITH HAD A HOLE IN HIS RIGHT EYE AREA THAT I WAS ABLE TO OBSERVE. I ESCORTED THE RESCUE SQUAD TO THE HOSPITAL AND MR SMITH WAS FLOWN TO ROANOKE MEMORIAL HOSPITAL.
 I ALSO SPOKE WITH MR SMITH CHILDREN NEIL SMITH, CRYSTAL SMITH, AND CHARLES SMITH JR. THEY ADVISED THAT THEY HAD BEEN SHOOTING MOST OF THE DAY. CHARLES SAID THAT THEY HAD SHOT THE BLACKPOWDER RIFLE ABOUT 50 TIMES BEFORE IT EXPLODED. THEY ALL ADVISED THAT THE SHOOTING WAS AN ACCIDENT.
